Federal Activities WH Federal-State Partnership


- Launched June 2022
- Supply Chain Working Group MOU under final review:



- With to-be-formed "Partner Associations," develop a coordinated, resilient, and sustainable regional OSW supply chain
- Address "national priority gaps"

Federal Activities (cont'd) FERC Order No. 2023

- 1. Implements new "first-ready, first-served" cluster study process
- 2. Applicants must demonstrate site control and commercial readiness
- 3. Increases speed of interconnection queue processing
- 4. Incorporates technological advances into process



- COP submitted April 2022
 Carolina Long Bay
- TotalEnergies

 - Anticipate Site Assessment Plans submitted this summer, ongoing stakeholder engagement

 - <u>CLEAN CAROLINAS</u>




State Activities (cont'd) Implementing MOUs
