Federal Activities Inflation Reduction Act

- Repeals OSW leasing moratorium
 With stipulations
- \$BILLIONS for clean energy
 - \$750M for permitting and review process improvement
 - Energy Investment Tax Credit expansion
 - Advanced Manufacturing Tax Credit
 - Grants and loans



Federal Activities Federal-State Partnership


- Launched June 23, 2022
 - > 11 East Coast Governors
 - DOE, DOI, and WH Climate Office
 - Industry and labor leaders
- Supply Chain Working Group




- To establish common definitions for domestic, regional, and local content






• DOE Floating OSW Shot








Floating Offshore Wind[™]

State Activities Carbon Plan Update


- HB951 Energy Solutions for NC
 Reduce power sector GHGs
 NCUC to develop Carbon Plan
- What the Parties Say About OSW?



- > Duke: spend up to \$325M to acquire DER project
- > Public Staff: not appropriate at this time (ATT), study for 2024
- > Atty Gen: 800MW/2029, should not allow for cost-recovery ATT
- CE Advocates: Study WEA most beneficial to ratepayers for 2024, continue permitting
- Tech Customers: should not allow for cost-recovery ATT

State Activities (cont'd) NSF Innovation Engine Application

- Clean Energy tech focus (i.e., on- and OSW, solar, clean H+, marine energy, and the energy delivery and storage systems that support grid integration
- Serving the Piedmont and Coastal Plains of NC and SC, focusing on areas east of I-95 within the Southeast Black Belt or "Southeast Crescent"




Pyramid of workforce development showing coordination between Clean ENGINES and STEPs4GROWTH in Clean Energy (CE).
