ACTION: Notice is hereby given that the 2024 North Carolina Consolidated Annual Performance Evaluation Report (CAPER) has been drafted by the North Carolina Department of Commerce, Rural Economic Development Division. The draft may receive several updates prior to submission to the U.S. Department of Housing and Urban Development (HUD).

SUMMARY: The 2024 North Carolina Consolidated Annual Performance Evaluation Report (CAPER) summarizes the 2024 accomplishments. The State's CAPER includes the following programs funded by (HUD: Small Cities Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), Housing Trust Fund (HTF), Emergency Solutions Grants (ESG), Rapid Unsheltered Survivors Housing (RUSH), and Housing Opportunities for Persons with AIDS (HOPWA) programs.
