**ACTION:** Notice is hereby given that the 2024 Annual Action Plan (AAP) Plan substantial amendment to add funding for the Rapid Unsheltered Survivor Housing-ESG Disaster Recovery (RUSH) Program has been drafted by the North Carolina Department of Commerce, Rural Economic Development Division. The draft may receive several updates prior to submission to the U. S. Department of Housing and Urban Development.

**SUMMARY:** The 2024 Annual Action Plan (AAP) establishes the federal investments and proposed actions of the four Consolidated Plan partner agencies. The document includes the following programs funded by the U.S. Department of Housing and Urban Development (HUD): Small Cities Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), Emergency Solutions Grants (ESG), Housing Opportunities for Persons with AIDS (HOPWA) programs.
