








FINISH LINE GRANTS



Finish Line Grants



Are you struggling financially to complete your degree or credential program?

A Finish Line Grant may be available to assist you.

Finish Line Grant funds are available to assist you with unforeseen financial emergencies such as: transportation, auto repairs, child care, dependent care, housing assistance, accommodations for individuals with disabilities, utility bills, referrals to health care, or assistance with books, tuition, fees, or school supplies.

Finish Line Grants are up to \$1,000 per semester/per student. Students must be in good academic standing and have completed at least 75% of their degree or eligible Continuing Education Program.

If you are experiencing a financial emergency, please visit your Student Services Office or your local NCWorks Career Center for more information.

Applications and required documentation must be returned to your local NCWorks Career Center for consideration.

In July 2018, Governor Cooper announced a new program, Finish Line Grants. The Finish Line Grant Program was established to assist community college students in completing their education when faced with unforeseen financial hurdles. The Region Q Workforce Development Board in partnership with Beaufort County Community College, Martin Community College, Pitt Community College, and Roanoke-Chowan Community College applied and was awarded Finish Line Grants. The Region Q Workforce Development Board requested \$100,000 with Beaufort County Community College receiving \$25,000; Martin Community College receiving \$20,000; Pitt Community College receiving \$35,000; and Roanoke-Chowan Community College receiving \$20,000.

Students can request up to \$1,000 per semester to help offset financial hurdles. To be eligible, students must have completed 75% of their degree, diploma, certificate or eligible Continuing Education program. Additional criteria can be found on the application. Allowable expenses are transportation, car repairs, child care, dependent care, housing, utility bills, medical referrals, accommodations for individuals with disabilities, and assistance with books and supplies. The purpose of the grants are to provide the financial support needed to allow the student to complete their education versus having to drop their classes.

With the impact of Hurricane Florence still lingering in our communities, we feel sure many students will benefit from these grant funds. Students can receive an application packet from their local NCWorks Career Center or their Community College. Once completed, the application and all supporting documentation must be returned to your local NCWorks Career Center for processing.

If you attend a College outside of our Region or live outside the Region and attend one of the Community Colleges in our Region, we still may be able to assist you. Visit your local Career Center to inquire before completing your application packet.

An added bonus – the Career Advisors will provide case management for each student receiving a Finish Line Grant. Case management could include but is not limited to job search, resume writing, interview prep, career exploration, and job placement services.

Do you have a **serious**
financial emergency?

SCC and the Finish Line Grant may be able to help!

To apply, you must:

- Be enrolled in a WIOA approved program - *See list on the back.*
- Have completed - *or be currently enrolled in* - 75% of your program requirements
- Hold a GPA of 2.00 or greater
- Meet with a member of SCC's Financial Aid team to get eligibility certified.
- The following **nine items** are needed to complete your application with the WIOA case manager in your county of residence:
 - Social Security card
 - Birth certificate
 - Proof of residency
 - Family size
 - Self-attestation of income
 - SCC certification of eligibility
 - Financial Aid award letter*
 - Selective service registration*
 - Veteran status (DD-214)***if applicable*

Please Note: Finish Line Grant funds are NOT paid directly to the student but rather to the agency/vendor, etc.

▶ ELIGIBILITY

REQUIREMENTS FOR A STUDENT TO RECEIVE A FINISH LINE GRANT:

- Have a good academic standing (GPA 2.0 or better)
- Have completed (or currently be enrolled in) at least 50% of a program's credit hours toward a certificate, diploma, or degree
- 18 years or older
- U.S. Citizen or authorized to work in the U.S.
- The maximum total amount of grant funds allowed per student is \$1,000 per program year (July 1– June 30)
- Financial emergency or unforeseen challenge with supporting documentation

▶ GRANT

FUNDS CAN BE USED FOR THE FOLLOWING TYPES OF NEEDS (PLUS OTHERS):

TRANSPORTATION: assistance may be provided to assist the student to get to the community college

TUITION AND FEES: assistance may be provided for students who have encountered financial hardship that has negatively impacted the student's ability to pay for tuition and fees

HOUSING: assistance may be provided to students to maintain or obtain adequate or temporary shelter while participating in educational activities.

UTILITY BILL: financial emergencies that prevent the payment of a utility bill (water, gas, and electric)

The Centralina Workforce Development Board (WDB) is proud to help community college students in our region who need assistance in getting across the “finish line” and complete their education. The Finish Line grants were created to assist students with financial hurdles such as healthcare costs, childcare expenses, or car breakdowns while completing their degree or trade. Since its rollout in the Summer of 2018, Finish Line Grants have assisted hundreds of community college students throughout the state. In the Centralina WDB, Finish Line grants were able to assist Stanly Community College student Taylor Ferree in her last semester of Respiratory Therapy training, including the license application fee and required seminars.



Taylor, the first recipient of a Finish Line grant in the Centralina WDB region, completed all required information and to had items paid for with guidance and assistance of Centralina Workforce Development Board Services Specialist Narissa Knight.

“It was a very easy process. I’m really grateful for everything,” said Taylor.

“This is another way that the Centralina Workforce Board is working with our partners, the community colleges, and others to improve the workforce in our communities,” said Kim Carpenter, Centralina NCWorks Deputy Project Director who also worked with Taylor.

Taylor will graduate this May from Stanly Community College with an Associate in Science degree in Respiratory Therapy.
