Sheetz to create 254 jobs at new Alamance County operation

Governor Bev Perdue announced Sept. 5 that Sheetz Inc., a large chain of convenience stores and gas stations, will establish a distribution and food manufacturing facility in Burlington. The company plans to create 254 jobs in North Carolina by the end of 2018, and invest more than \$32.8 million in its Alamance County facility. The project was made possible in part by state grants from the Job Development Investment Grant and the One North Carolina Fund. The N.C. Department of Commerce's Margie Bukowski was the developer on this project.

"Companies like Sheetz recognize that North Carolina is a great place to thrive because of our top-notch business climate, well-trained workforce, and a strong logistics network that fits the company's needs," said Perdue. "We're going to keep leveraging North Carolina's tremendous assets as we continue our focus on job expansion."

Sheetz Inc., founded in 1952, is a family-owned convenience store chain based in Altoona, Penn. The company operates more than 425 locations across six states - Pennsylvania, Maryland, Virginia, Ohio, West Virginia, and North Carolina - and employs more than 14,500 employees. Read more.

Leviton to bring 152 jobs to Burke County

Governor Bev Perdue announced Sept. 10 that Leviton Manufacturing Company, Inc., a leading manufacturer of electrical wiring, lighting control, power cables and other electrical products, will expand its manufacturing operations in Morganton. The project was made possible in part by a Job Development Investment Grant. To meet the targets established in this performance-based grant, the company plans to create 152 jobs over three years and make a capital investment of \$7.3 million in Morganton. The N.C. Department of Commerce's Bill Payne was the developer on this project.

Small business rally held in WNC

The 2nd Annual Business and Innovation Resource Rally was held at the main campus of Tri-County Community College in Murphy on Aug. 17. Federal grant to boost manufacturing in Eastern N.C

The N.C. Rural Economic Development Center and partnering organizations will launch an intensive effort this fall to stimulate manufacturing growth in a six-county region of Eastern North Carolina.

The long-term project will focus on strengthening aerospace and automotive manufacturing in Lenoir, Greene, Wayne, Wilson, Edgecombe and Pitt counties.

The Industrial Extension Service of N.C. State University and the N.C. Small Business and Technology Development Center of the University of North Carolina System will partner with the Rural Center to provide technical assistance to new and existing businesses. North Carolina's Eastern Regional Partnership, an economic development group, also is collaborating on the project.

In the seminar, featured speaker MethodSense CEO Rita King shared information about the overall process including:

Along with a staff of more than 60 researchers, economists, statisticians, and policy analysts, Assistant Secretary for Labor and Economic Analysis Stephanie McGarrah is responsible for the overall direction and management of the division including administration, data collection, research, analyses, reporting and dissemination of information on the state's economy, labor force, educational and workforce-related issues. Originally from Henderson, Economic Developer Tim Ivey works in the N.C. Department of Commerce's Northeastern Regional office in Edenton. A finance major, he is a 1990 graduate of the University of North Carolina at Wilmington. Before joining Commerce in 2006, Ivey owned and operated a furniture manufacturing company with 28 employees.

Ivey points to two projects that he recently worked on with his economic development partners in northeastern North Carolina that exemplify the state's assets. Those are Gunboat and The Marco Company. According to Ivey, both of these companies are perfect fits for northeastern North Carolina due to the skill sets of the region's citizens and the region's proximities to natural assets such as water or infrastructure such as roads.

Gunboat is a catamaran boat builder that was experiencing manufacturing difficulties in China due to a high employee turnover rate, low quality and high energy costs. "Gunboat's intentions of 'reshoring' those jobs to the U.S. gave us an opportunity in North Carolina to display our quality of labor available in the marine industry and an excellent existing building in Dare County at the Wanchese Industrial Park," explained Ivey.

The Marco Company is a shelving, kiosk and display manufacturer based in Texas. Its business plan called for a sister manufacturing plant on the East Coast, with access to good roads and markets in the Mid-Atlantic and Southeastern U.S. A home-grown business of

400 employees, The Marco Company prefers to be situated in less populated areas, but with good employee skill sets in the cabinetry and mechanical areas, which is why the company chose Jamesville in Martin County this past June, according to Ivey.

In order for northeastern North Carolina to be competitive among executives and site selection consultants, Ivey believes that developing suitable sites and re-emphasizing the semi-skilled talents of the region's workforce are very crucial.

"I would like to see every county school system require its high school students to receive a 'Career Ready Certificate' before graduating," suggested Ivey. "I also believe that every county needs a 'Certified Industrial Site' that will offer companies a 'shovel-ready' site for the expansion or relocation of a business. Having a qualified site and labor are always attractive to any business or site consultant. The consultants want to close deals; we just have to make it easy for them to achieve that goal."

Ivey lives in a small community called Merry Hill located between Windsor and Edenton. In his spare time he enjoys spending time with his friends, his three sons (Jeb, Ben and Gillam) and his wife of 17 years, Pat. Ivey also coaches soccer and baseball and plays golf.

Kernersville site picked for VA center that

released

The N.C. Biotechnology Center has issued the third in its long-running series of reports on employment trends in North Carolina's biomanufacturing sector. Window on the Workplace 2012 provides an assessment of the workforce needs of the state's biomanufacturing and pharmaceutical-manufacturing sector. The report focuses on a group of 54 production and manufacturing companies which share similarities in jobs, process technology, and regulatory oversight, and have been a strategic focus for North Carolina economic development.

The publication is based largely on survey data collected in 2007 and 2011 as well as face-to-face interviews with company representatives. The report addresses job growth, education levels and trends related to recruiting, hiring, and training. Among other findings, the report indicates that North Carolina biomanufacturing employers are able to recruit approximately 90 percent of their hires locally, searching nationally and globally only for some specialized scientists and engineers.
