Cree to add 244 jobs in Durham

Gov. Bev Perdue announced Sept. 20 that Cree Inc., a global leader in LED lighting technology and products, will expand its manufacturing operations in Durham. The company plans to create 244 jobs over the next two years and invest \$135 million. The project was made possible in part by a state grant from the Job Development Investment Grant program.

"Cree is a homegrown success story," said Perdue. "Not just because they started here and grew into a global leader in efficient lighting technology, but also because North Carolina's top-notch workforce and top-rated business climate helped encourage them to stay, expand and thrive here at home." The N.C. Dept. of Commerce's Vivian Powell was the developer on this project.

Empire Foods to bring 200 jobs to Halifax County

Gov. Bev Perdue on Sept. 16 announced that Empire Foods Inc., an advanced-technology food processing company, will bring 200 jobs to Halifax County. The company, using technology licensed from N.C. State University, plans to create the jobs and invest \$2.5 million over the next five years. The project was made possible in part by a \$400,000 grant from the One North Carolina Fund. The N.C. Dept. of Commerce's Garrett Wyckoff was the developer on this project.

"These 200 new jobs are the result of North Carolina's exceptional ability to bring together innovation, economic development, our renowned university system and local and state partnerships," said Perdue. "This creative collaboration will also benefit local farmers, successfully combining new production technology with our traditional agricultural heritage."

Empire Foods Inc. is a state-of-the-art food processing company that uses technology to produce shelf-stable food products. The products do not require refrigeration, but maintain the flavor, color and nutrients of fresh food. The company will lease a 35,000square-foot production facility to be built by the county at the new Halifax Corporate Park. It will produce fruits and vegetables with an initial focus toward military and restaurant markets. In addition to creating jobs at the production facility, the company will purchase

Manufacturer to bring 68 jobs to Guilford County

Gov. Bev Perdue on Sept. 17 announced that Baltek Inc., a manufacturer of core materials for the wind energy, mass transit, marine and military markets, will relocate to a new manufacturing facility in Guilford County. The company plans to create 68 jobs and invest \$3.25 million over the next three years in High Point. The project was made possible in part by a \$204,000 grant from the One North Carolina Fund. The N.C. Dept. of Commerce's Rod Forsythe was the developer on this project.

"Creating jobs is my number one priority. North Carolina continues to attract businesses in cutting-edge industries that bring highly desirable jobs to our state," said Perdue. "Our skilled workers, custom training programs and top-rated business climate remain top draws for companies from around the world looking for the best location to succeed."

"The consolidation and relocation of Baltek's activities to High Point is of strategic significance to the business. High Point will provide us a solid basis from which we can continue to competitively serve our customer base into the future," said Pierre Monéton, president of Core Materials of 3A Composites. "We are most appreciative of Gov. Perdue and Sec. Crisco for their dedicated efforts to make this project a reality in North Carolina." <u>Read more</u>.

N.C. among states leading comeback from recession

Texas, North Carolina, Idaho and a handful of other states are leading the nation's crawl out of the worst recession since the 1930s, a USA TODAY analysis finds.

Since the recession officially ended in June 2009, a group of about 10 states that have outperformed the nation almost continuously for 25 or more years again is generating new income at a faster pace than the rest of the nation.

N.C. State University has its own stimulus plan for the state economy: a new initiative to double the number of private companies it spins off every year, and to boost by 50 percent annually the amount of grants and contracts its faculty and staff win to fund research.

NCSU will open an "innovation hub," where companies can come to gain access to expertise and technology that university researchers are developing, and where faculty and staff can get support to market their technologies or create new companies based on their work, Chancellor Randy Woodson told the Board of Trustees on Sept. 24.

The N.C. economy is likely to grow this year, but the recovery will remain uneven and jobs will remain scarce, a UNC-Charlotte economist told The Charlotte Observer Sept. 15.

Cleveland Community College breaks ground on LeGrand Center

N.C. Dept. of Commerce Sec. Keith Crisco was on hand Sept. 14 for the groundbreaking of the new LeGrand Center at Cleveland Community College in Shelby. The new building will house the CCC continuing education department, classrooms for Cleveland Early College High School students and space for businesses to hold conferences, workshops, meetings and events. CCC's Board of Trustees, the Cleveland County Board of Education and county commissioners joined together to work as a team, and with the assistance from the LeGrand family, the building is ready for the construction phase.

The project is estimated to cost about \$18.7 million with participating groups sharing the cost.

The "topping off" ceremony is a construction industry tradition considered good luck for a new building. N.C. Dept. of Commerce Sec. Solicitation open for Board of Science and Tech's Matching Funds Program

The N.C. Board of Science and Technology is pleased to announce the release of the FY 2011 solicitation for the One NC Small Business Phase I SBIR/STTR Matching Funds Program. The program provides matching grants to North Carolina companies that have received a Phase I SBIR or STTR grant during the program's solicitation period.

Companies whose principle place of business is in North Carolina and who receive a Phase I SBIR or STTR grant between July 1, 2010, and June 30, 2011, are eligible to apply. Unlike in FY 2010, companies that have previously received a matching grant under the program ARE eligible to apply for a matching grant. Matching grants will be awarded to eligible companies on a first-come, first-served basis until funding is exhausted.

In its five-year history, the Matching Funds Program has awarded more than \$15 million to more than 200 small businesses throughout North Carolina. Additional information, including the FY 2011 solicitation, is available on the board's <u>Web site</u>. economy to increase 0.8 percent over 2009, he said during his quarterly economic presentation, delivered at UNCC's uptown campus.

That's a downgrade from his earlier reports: In June, Connaughton predicted 2.2 growth; in March, he said the state's economy was likely to grow by 3.5 percent over 2009.

"The national economy has been able to put together four consecutive quarters of expansion, while the North Carolina economy has struggled to put two quarters of growth together," he said.

Commerce participates in Fort Bragg briefing

N.C. Dept. of Commerce Legislative Director Rita Harris and Director of Foreign Operations Derek Chen attended an event sponsored by the XVIII Airborne Corps and Fort Bragg, which included a command brief by LTG Frank Helmick. This brief provided information on Fort Bragg's mission, operations within the XVIII Airborne Corps, domestic missions, and how the corps is able to mobilize and deploy when crises occur or as directed by the Pentagon or FORSCOM.

In addition, Helmick cited numerous metrics related to Fort Bragg. The base supports the largest population of civilians and soldiers of any U.S. Army base in the world, and boasts the largest economic impact, which is estimated at \$9.3 billion annually. It also ranks number one among Army bases in terms of its libraries, airfields, railroad lines and retail facilities.

The group attended additional briefings on outload nodes, green ramp activities, and an airborne operations demo which included over 1,100 paratroopers and a heavy equipment drop.
