Governor Cooper Announces 1,229 New Jobs as AvidXchange Expands in Mecklenburg County

Governor Roy Cooper was in Charlotte earlier today (December 18) to announce that AvidXchange, a leading fintech provider of accounts payable (AP) and payment automation solutions, will expand its Charlotte headquarters, creating 1,229 jobs.

The company, an industry leader in automating invoice and payment processes for midmarket companies spanning multiple industries, will invest \$41 million in Mecklenburg County.

"North Carolina leads the nation in the IT and financial services industries," **Governor Cooper** said. "North Carolina's talented workforce helps companies like AvidXchange develop big ideas and build innovative products."

AvidXchange provides cloud-based software that simplifies the way companies pay their bills. The company has been

Sonic Automotive Will Create 500 Jobs in Gaston County

Sonic Automotive will open a marketing resource and customer contact center in Gaston County, creating 500 jobs, **Governor Roy Cooper** announced December 13. The Fortune 500 company, one of the largest automotive retailers in the United States, will make an \$11.2 million investment in Lowell to establish the center.

An event was held at the Gastonia Conference Center to celebrate the announcement. **N.C. Commerce's Chief Deputy Secretary Liz Crabill** offered remarks announcing the project's details on behalf of the Governor.

"Fortune 500 companies like Sonic have many choices when searching for a new location," said **Governor Cooper**. "I'm pleased that North Carolina's strengths including our outstanding workforce and commitment to workforce training - are paying off once again."

Sonic Automotive, with corporate headquarters in Charlotte, operates more than 100 new vehicle sales franchises in 13 states and eight EchoPark used vehicle sales operations. The new facility will be a national call center, supporting the company's sales operations across the United States.

"North Carolina remains our home," said **David B. Smith, CEO of Sonic Automotive**.

"We launched AvidXchange 18 years ago in a coffee shop in Charlotte with five employees. Since then, we've grown to 1200 employees, proud to call North Carolina home," said **AvidXchange CEO, Michael Praeger**. "I'm thrilled to have the State's continued support as we look to double our employee base in the next five years."

"AvidXchange offers a great example of North Carolina's entrepreneurial spirit," said **North Carolina Commerce Secretary Anthony M. Copeland**. "This homegrown company shows our state provides everything companies need, through every stage of their growth cycle."

AvidXchange will add a variety of positions with this expansion, including software development, financial, marketing, and professional services personnel. Salaries for the new positions will average \$68,569, which is higher than the current Mecklenburg County average wage of \$65,285.

AvidXchange was awarded a Job Development Investment Grant (JDIG) earlier today to help facilitate the company's expansion. Over the course of the 12-year term of this grant, the project will grow the state's economy by an estimated \$2.6 billion. The company could see payments of up to \$19.6 million from the grant, spread over 12 years and provided the company hits its performance targets.

Because AvidXchange chose to expand in Mecklenburg County, classified by the state's economic tier system as Tier 3, the company's JDIG agreement also calls for moving as much as \$6.5 million into the state's Industrial Development Fund -Utility Account. The Utility Account helps rural communities finance necessary infrastructure upgrades to attract future business.

Partnering with the <u>North Carolina Department of Commerce</u> and the <u>EDPNC</u> on this project were the <u>North Carolina General</u> <u>Assembly, the North Carolina Community College System,</u> <u>Duke Energy, Mecklenburg County, the City of Charlotte, and</u> the Charlotte Regional Business Alliance.

"Companies that know North Carolina well continue to expand in our state," said **North Carolina Commerce Secretary Anthony M. Copeland**. "Sonic Automotive's decision is the latest vote of confidence in North Carolina's strengths as a business location."

Sonic Automotive will add a variety of positions with this expansion, including support agents, managers, and marketing personnel. Salaries for the new positions will average \$53,219, above the current Gaston County average wage of \$38,780.

A Job Development Investment Grant (JDIG) could provide the company up to \$6.8 million, paid over 12 years. Over the life of the grant, the project will grow the state's economy by an estimated \$518 million. As much as \$755,000 could go into the state's Utility Account, as Gaston is a Tier 2 county.

Partnering with <u>N.C. Commerce</u> and the <u>Economic Development Partnership of N.C.</u> on this project were the <u>North Carolina</u> <u>General Assembly</u>, the <u>North Carolina</u> <u>Community College System</u>, <u>Gaston County</u>, the <u>City of Lowell</u>, and the <u>Gaston County</u> <u>Economic Development Commission</u>.

Lending Tree's headquarters expansion in Mecklenburg County will be facilitated, in part, by a Job Development Investment Grant (JDIG). Over the course of the 12-year term of this grant, the project will grow the state's economy by an estimated \$969 million. Using a formula that accounts for the new tax revenues generated by the new jobs, the JDIG agreement authorizes the potential reimbursement to the company of up to \$8,373,000 spread over 12 years.

Because Lending Tree chose to expand in Mecklenburg County, classified by the state's economic tier system as Tier 3, the company's JDIG agreement also calls for moving as much as \$2,791,000 in new tax revenue generated through the grant into the state's Industrial Development Fund - Utility Account.

Rural Communities Receive Nearly \$7.3 Million in Grants, Attracting 240 New Jobs

The North Carolina Rural Infrastructure Authority (RIA) approved seven grant requests totaling \$7,275,100 at its December 13 board meeting. The requests include commitments to create a total of 407 jobs, 167 of which were previously announced. The public investment in these projects will attract more than \$95 million in private investment.

"Rural North Carolina communities have a lot to offer families and businesses, and they need infrastructure that complements those unique assets," said **Commerce Secretary Tony Copeland**. "These new Rural Infrastructure Authority grants will help invest in that infrastructure and support the creation of good jobs across our state."

"The projects approved today will attract hundreds of new jobs, support business expansion and prepare sites for future growth in rural areas of North Carolina," said **Assistant Secretary for Rural Economic Development Kenny Flowers**. "The Rural Economic Development Division at Commerce and the Rural Infrastructure Authority work closely with leaders in our rural communities to help them expand economic opportunity and investment."
