Honeywell, a Fortune 100 company providing software-oriented solutions for many of the world's most complex industries, will locate its headquarters in Mecklenburg County, creating 750 jobs by the end of 2024, including 150 that are currently based in New Jersey. The company's move will bring more than \$248 million in investment by the end of 2023.

"With our strong talent, robust infrastructure and unmatched quality of life, including our commitment to education and our low cost of living, North Carolina is the ideal headquarters choice for an elite company like Honeywell," said **Governor Roy Cooper**. "Charlotte is perfectly positioned to provide the education and training, infrastructure and amenities to attract and retain Honeywell's top talent."

"As our new corporate global headquarters, Charlotte provides Honeywell with many advantages in support of our ongoing transformation and emergence as a premier technology company," said Darius Adamczyk, Honeywell chairman and

### Secretary Copeland Visits Halifax County for Job Announcement, Hometown Strong Visit

**North Carolina Commerce Secretary** Anthony M. Copeland had a busy day in Halifax County last Thursday (November 29), including keynoting an economic development event announcing 79 jobs to the

Governor Cooper announced Reser's Fine Foods will expand its current operations in Halifax County, creating 79 jobs over the next 5 years, and Secretary Copeland brought word of the Governor's announcement to a group gathered at the company's facility in

"Halifax County is a prime location for manufacturers with strategic access to rail and road transport," said Commerce Secretary Anthony M. Copeland. "That transportation and distribution infrastructure, coupled with an experienced manufacturing workforce, made it the right choice for Reser's to stay in North Carolina."

"Our tortilla business continued to grow in the Eastern United States over the past 9 years,

chief executive officer. "We selected Charlotte because it offers a great business environment along with access to a workforce that has the skillset Honeywell will need to be competitive over the coming decades. In addition, the location allows us to co-locate Corporate headquarters with our Safety and Productivity Solutions business, it is near our Honeywell Building Technologies and Honeywell Connected Enterprise businesses in Atlanta, and it offers our employees a great quality of life. At the same time, we will retain a large workforce in New Jersey."

Salaries for the new employees in North Carolina will vary by position and experience. Once all positions are filled, the annual payroll impact will be more than \$250 million.

Honeywell's headquarters location in Mecklenburg County will grow the state's economy by an estimated \$7.9 billion, over the 12 years of its Job Development Investment Grant (JDIG), which was approved by the state's Economic Investment Committee Monday evening (December 3). The JDIG agreement authorizes the potential reimbursement to the company of up to \$42,450,000 spread over 12 years. As much as \$14.1 million in new tax revenue generated through the grant will go into the state's Industrial Development Fund - Utility Account.

Partnering with N.C. Commerce and the Economic Development Partnership of North Carolina on this project were the North Carolina General Assembly, the North Carolina Community College System, Mecklenburg County, the City of Charlotte, and the Charlotte Regional Business Alliance.

# Raleigh Tech Company Pendo to Expand Headquarters and Add 590 Jobs

Pendo, a growing technology company founded in Raleigh, will more than triple its local operations over the next five years, adding 590 jobs and investing \$34.5 million in Wake County, **Governor Roy Cooper** announced yesterday (December 3).

"North Carolina is home to many of the best tech minds in the industry, and Pendo grew out of that innovative culture," said **Governor Cooper**. "As homegrown companies evolve, they get

They use Pendo to understand how users journey through their web and mobile applications, and provides tools to onboard and educate those users, collect feedback, and ultimately, to increase product adoption and engagement.

"Our mission at Pendo is big and bold - we want to improve society's experience with software," said **Todd Olson, CEO** and co-founder of Pendo. "To achieve that, we need to continue to find the best talent and offer them an amazing place to work. With its first class universities, hub of technology companies, and incredible quality of life, North Carolina, and specifically Raleigh, offers the perfect setting for our team to grow."

This project will provide Pendo with a corporate headquarters location and facility to accommodate rapid growth. This location will be the company's primary engineering hub, with dozens of software engineers and product managers, as well as its center for sales, marketing, customer success, and back office functions such as finance and human resources. Salaries will vary by position and experience. Once all positions are filled, the average salary is expected to be \$86,824. The average salary in Wake County is \$56,245.

"Pendo had an attractive offer to leave Raleigh, but our talent pipeline, top-tier universities and our stable and favorable business climate won out against competitors," said North Carolina Commerce Secretary Anthony M. Copeland. "I look forward to Pendo's continued success here."

A Job Development Investment Grant (JDIG) worth up to \$8,788,500 to the company, spread over 12 years, will help facilitate the expansion. The state expects the project will grow our economy by an estimated \$1.2 billion over those 12 years. As \$2.9 million in the new tax revenue generated through the grant will go into the state's Industrial Development Fund - Utility Account. The Utility Account helps rural communities finance necessary infrastructure upgrades to attract future business.

Partnering with N.C. Commerce and the Economic Development Partnership of North Carolina on this project were the North Carolina General Assembly, the North Carolina Community College System, Wake County, the City of Raleigh, Wake County Economic Development, the City of Raleigh Office of Economic Development and Innovation, and the Greater Raleigh Chamber of Commerce.

## 2019 Tier Rankings Released

The North Carolina Department of Commerce released the county tier designations for 2019 on November 30. The designations, which are mandated by state law, play a role in several programs that assist in economic development.

The new rankings comply with changes made by the North Carolina General Assembly that alter the formula used to calculate final tier designations. These changes, implemented with the adoption of the 2018 Appropriations Act (S.L. 2018-5, Section 15.2.a), eliminate several 'adjustment factors' previously incorporated into the methodology.

28 counties will change tier designations for 2019.

Counties moving to a less distressed tier ranking include Alleghany, Ashe, Camden, Cherokee, Clay, Jackson, Macon, McDowell, Montgomery, Person, Yadkin, and Yancey (from Tier 1 to Tier 2); and Currituck and Davie (from Tier 2 to Tier 3).

Counties moving to a more distressed tier ranking include Beaufort, Cleveland, Cumberland, Duplin, Hoke, Nash, Rockingham, Rutherford, Sampson, Surry, Wayne, and Wilson (from Tier 2 to Tier 1); and Carteret and Granville (from Tier 3 to Tier 2).

Advance Auto Parts will designate Raleigh as its corporate headquarters and expand operations in Wake County by adding up to 435 new jobs over five years, **Governor Roy Cooper** announced November 28.

"Advance is expanding its technology, data analytics and eCommerce capabilities in North Carolina because we have the talent, training opportunities, education system and industry expertise to make this venture a success."

A Job Development Investment Grant (JDIG) will help facilitate the company's move. # Manufacturer Chooses Halifax County for New Facility

## **Gaston County for First U.S. Plant**

Era Polymers Corporation, an Australian manufacturer specializing in polyurethane chemistry, will open its first industrial facility in the United States, creating 20 new jobs in Gaston County, **Governor Roy Cooper** announced November 21. The company plans to invest \$9.2 million in Stanley.

"Advanced manufacturers from around the world continue to choose North Carolina as the ideal place to expand," **Governor Cooper** said. "Our skilled workforce combined with our central east coast location enable international companies that locate here to serve customers efficiently across the United States and North America."

Era Polymers, with headquarters in Sydney, Australia, produces a diverse line of polyurethane products sold in over 70 countries worldwide. The new manufacturing operation in Stanley, the first American plant for the company, will join four other production facilities operated by the company in Australia, New Zealand and South Africa. Strong sales growth in North America led the company to search for a new business location in the United States.

"Era Polymers has been conducting business within the USA for more than 15 years," said **George Papamanuel, President of Era Polymers**. "It became a logical step for us to establish our own presence in the USA with an advanced manufacturing facility, to better supply and technically service our growing customer base." Mr. Papamanuel expressed pleasure with the support received from the North Carolina Department of Commerce and added, "the support from local, county and state authorities made a compelling case to locate our facility in Stanley N.C. This world class facility is the ideal platform to support the next growth stage of our company."

Taking into consideration all of the new positions announced today, the average annual wage of the new jobs will be \$66,250. The average wage in Gaston County is currently \$38,780.

A performance-based grant of \$50,000 from the One North Carolina Fund will help facilitate Era Polymers' move into Gaston County.

Partnering with the North Carolina Department of Commerce and the EDPNC on this project were the North Carolina General Assembly, the North Carolina Community College System, Duke Energy, Gaston College, the Gaston County Board of Commissioners, the Town of Stanley, Wake County Economic Development, and the Gaston County Economic Development Commission.

# Opportunity Zone Workshop Hosted by the Federal Reserve Bank Coming to Raleigh December 13

The Federal Reserve Bank of Richmond will convene an information workshop in Raleigh to provide local community leaders and economic developers with more information regarding Opportunity Zones, the federal initiative aimed at bringing more investment to economically distressed areas across the country.

The event, hosted by the Federal Reserve Bank, will be held December 13 starting at 8:30am at the McKimmon Center in manufacturer, will open a new plastic film manufacturing facility in Halifax County, creating 50 jobs, Governor Roy Cooper announced November 29. The company plans to invest \$11 million in Weldon with the project.

"JBB Packaging chose this location at the Becker Industrial Park because it was formerly used for plastics manufacturing, it has the space they need now and for future growth, and it's half a mile from Interstate 95," said Commerce Secretary Anthony M. JBB Packaging will recycle plastics and produce flexible packaging and garment bags. The new facility moving into the Flambeau Building in Becker Industrial Park will host state-of-the art equipment producing the highest quality at the most affordable cost.

A performance-based grant of \$150,000 from the One North Carolina Fund will help facilitate JBB Packaging's move to Halifax County. The One NC Fund provides financial assistance to local governments to help attract economic investment and to create jobs. Companies receive no money upfront and must meet job creation and capital investment targets to qualify for payment. All One NC grants require a matching grant from local governments and any award is contingent upon that condition being met.

Partnering with the North Carolina Commerce and the Economic Development Partnership of North Carolina on this project were the North Carolina General Assembly, the North Carolina Community College System, North Carolina Railroad, Halifax County, and the Halifax County Economic Development Commission.
