





Purpose: To transmit adjusted Workforce Innovation and Opportunity Act (WIOA) funding levels for Program Year (PY) 2019 Dislocated Worker Local Area Allocations under WIOA Title I Section 132(c). To rescind PS 04-2019, Change 1.

Background: The U.S. Department of Labor (USDOL) released WIOA Allotments for PY 2019 (July 1, 2019 – June 30, 2020) for Adult, Dislocated Worker and Youth Activities in Training and Employment Guidance Letter (TEGL) No. 16-18. The state allotments are based on funds appropriated to the U.S. Department of Labor (USDOL) by the United States Congress through the Consolidated Appropriations Act, 2019, Public Law 115-245 on September 28, 2018.

TEGL 16-17, announcing the Dislocated Worker allotment levels for PY 2018, alerted states to the recapture and reallocation of funds provisions, and notified states that any recapture/reallocation of funds based on obligation of PY 2018 Dislocated Worker funding would impact PY 2019 Dislocated Worker allotments

In the Fiscal Year 2019 Appropriations Act, Congress appropriated Dislocated Worker PY 2019 funds in two portions: 1) funds available for obligation July 1, 2019 (i.e., PY 2019 “base” funds), and 2) funds available for obligation October 1, 2019 (i.e., Fiscal Year 2020 “advance” funds). Together, these two portions make up the total PY 2019 WIOA funding. TEGL 16-18 announced the Dislocated Worker allotment levels for PY 2019.

The attached charts provide the July and October portions of the Program Year 2019 (PY 2019) Local Area WIOA Dislocated Worker allocations. The funds will be distributed in October.

Action: The attached allocation charts are to be used for planning and operating PY 2019 Workforce Innovation and Opportunity Act Title I Programs under the PY 2019 Local Workforce Development Board Plans. All charts are provided for easy reference. Only the Dislocated Worker funds will show the “adjusted” amounts.

Local Workforce Development Boards will be administered funds by Notice of Funding Availability (NOFA) through the Workforce Information System Enterprise (WISE) system, once funds have been received from U.S. Department of Labor.
